**ORDER**

The Conditional Affiliation for starting a new Self-financing Law College viz. Nehru Academy of Law, Lakkidi, Mangalam, Palakkad under Nehru College of Educational and Charitable Trust with 3-year LLB and 5-year BBA-LLB programmes of 60 intakes each, for the academic year 2015-16, was granted vide U.O read as 1<sup>st</sup> and Confirmation of Conditional Affiliation was granted vide U.O read as 2<sup>nd</sup> .

2. Provisional affiliation was granted to 5 year BCom, LLB(Hons) programme with an intake of 60 for the academic year 2021-22 implementing judgement dated 29.07.2021 in W.P.(C) No.12212/2021 from Hon'ble High Court of Kerala, vide U.O read as 3<sup>rd</sup> .

3. Additional affiliation was granted to 2 year LLM programme with an intake of 15 for the academic year 2023-24 with permission to start the class for the academic year 2024-25 vide U.O read as 4<sup>th</sup> .

4. Continuation of Provisional Affiliation to 3 year LLB, 5 year BBA, LLB (Hons) & 5 year B.Com, LLB (Hons) programmes with an intake of 60 students each for the academic year 2023-24 was granted on conditional basis subject to the submission of approval order from Bar Council of India and renewal NOC from Government of Kerala for the year 2023-24, vide U.O read as 5<sup>th</sup> .

5. The Bar Council of India, vide paper read as 6<sup>th</sup> , has granted extension of provisional/ temporary approval for the 3-year LLB, 5-year BBA-LLB (Hons) and 5 year BCom, LLB (Hons) programmes for the academic year 2023-24.

6. The Dept. of Higher Education, Govt. of Kerala has renewed the NOC for the 3-year LLB,5-year BBA-LLB(Hons) and 5 year B Com, LLB (Hons) programmes for the academic year 2023-24 vide G.O read as 7<sup>th</sup> .

7. The Principal vide paper read as 8<sup>th</sup> , has requested for Continuation of Provisional Affiliation to 3-year LLB, 5-year BBA-LLB (Hons), 5-year BCom-LLB (Hons) and 2 year LLM programmes for the



academic year 2024-25.

8. Considering the above, the Vice Chancellor has accorded sanction

(i) to grant Continuation of Provisional Affiliation to the following programmes and intake as detailed below in Nehru Academy of Law, Lakkidi, Palakkad for the academic year 2024-25 on conditional basis subject to the submission of approval order from Bar Council of India and renewal NOC from government for the academic year 2024-25

(ii) for making the U.O read 5<sup>th</sup> as absolute, since the College has produced renewal NOC and extension of approval from BCI for the academic year 2023-24.

9. Orders are issued accordingly with the following terms and conditions:

- Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for CPA for the ensuing years remitting the fee fixed by the University, along with the extension of approval orders, if any, from the apex bodies concerned.
- Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
- In the light of the directions of the Hon'ble Supreme Court of India in WP (C) 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- Conduct of University. Examinations of any sort including that of S.D.E Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
- The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2024-25.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Violation of any of the above may lead to the cancellation of affiliation.
